The renovation won an award for Restoration in the 2019 Faith & Form/IFRAA International Awards Program.

The Church of St. Vincent de Paul, Interior Renovation - Albany, NY

Principal and Designer for the renovation of a 1908 classical Roman Catholic Church, which included a new central altar platform, baptismal font, finishes, lighting, restroom, installation of air conditioning, and a "wall of saints." The renovation won an award for Liturgical & Interior Renovation in the 2015 Faith & Form/IFRAA International Awards Program.

Troy Public Library, Hart Memorial Building - Troy, NY

Principal and Designer for the addition of a new elevator within the existing building envelope. The second floor of this distinguished American Renaissance Style library was inaccessible to those who could not climb the marble staircase. The project included threading a new hydraulic elevator through 3 levels of masonry arch construction and underpinning for the elevator pit. The design provided relocated restrooms on the first floor, a new restroom on the second floor, and staff break room and kitchen in the lower level. Interior upgrades were provided throughout the office space.
